**BILL FOR**

Long title

A Law to appropriate monies out of the Consolidated Revenue Fund and Capital Development Fund to the service of Akwa Ibom State Government and for other matters connected therewith.

Commencement.

(1<sup>st</sup> January, 2021)

Enactment.

**BE IT ENACTED** by the Akwa Ibom State House of Assembly as follows:

Issue of  
**₦214,799,917,250** and  
**₦241,450,752,750**

Consolidated Revenue  
Fund and Capital

Capital respectively.

1. The Accountant General of Akwa Ibom State may, during the year ending on the 31<sup>st</sup> day of December, 2021, and when authorized so to do by warrants issued by the Government of Akwa Ibom State, pay respectively out of the Consolidated Revenue Fund the sum specified by warrants, not exceeding in Fund the aggregate **Two Hundred and Fourteen Billion, Seven Hundred and Ninety Nine Million, Nine Hundred and Seventeen Thousand, Two Hundred and Fifty Naira** and out Of Capital sums specified by warrants, not exceeding in the aggregate **Two Hundred and Forty One Billion, Four Hundred and Fifty Million, Seven Hundred and Fifty Two Thousand, Seven Hundred and Fifty Naira.**

Appropriation of

Schedules 1 and 2.

2. The amounts mentioned in section 1 of this Law shall be appropriated to the Heads of Expenditure respectively, as set out in schedules 1 and 2 of this Law.

Prohibition to issue  
funds after 31<sup>st</sup>  
December, 2021.

3. No part of the amounts mentioned in section 1 of this Law shall be issued out of the respective funds named after 31<sup>st</sup> day of December, 2021.

Delegation of power  
of issuing warrants.

4. (1) The power of the Governor to issue Warrants under Section 1 of this Law is hereby delegated to the State Commissioner for Finance.

(2) Notwithstanding the provisions of sub-section (1) of this section, the Governor may by himself exercise the power to issue warrants under this Law.

Short Title and  
Commencement.

5. This Law may be cited as the Appropriation Law, 2021 and shall come into force on the 1<sup>st</sup> day of January, 2021.
